As part of a project implemented by the International Organization for Migration (IOM) and funded by the State Secretariat for Migration of the Swiss Confederation, IOM is looking for a highly experienced **Senior Data Analyst**, who has relevant expertise in the following fields:

1. Nature of the consultancy:

In the context of IOM's support to the Public Services Development Agency (PSDA) of the Ministry of Justice of Georgia in developing the capacities and potentials of the Unified Migration Data Analytical System (UMAS), IOM is soliciting expressions of interests for one specific function to be occupied by an IT expert, as outlined under section 4 below.

2. Project Context and Scope:

IOM has been supporting the PSDA in building capacities of the Unified Migration Data Analytical System (UMAS). This system has been developed as the central repository of migration-related data that are collected by the line ministries in Georgia that carry responsibility for the registration of foreigners in Georgia.

IOM's technical support to the UMAS, administered under a project funded by the State Secretariat for Migration of the Swiss Confederation, will aim at bolstering capacities in the PSDA and the contributing line ministries to analyse migration data and build evidence, based on which the SCMI and its constituent entities can develop policies and institutional mechanisms to deal with evolving migration challenges.

The PSDA requires technical support, which is available at the Georgian market, to offer the following support services to:

- 1) Finalize the integration of employment records of labour migrants from the Ministry of IDPs from the Occupied Territories, Labour, Health and Social Affairs (MoLHSA) into UMAS:
 - Create data model and integrate it into the UMAS core data model.

- Implement program units (“Jobs”) through which the data will be processed from source to report delivery platform.
- Integrate program units (“Jobs”) into the automation software (“Airflow”).
- Implement at least one report where MoLHSA data will be used.

2) Finalize the migration of Revenue Service data from the old to the renewed version of UMAS:

- Implementation of the program units (‘Jobs’) that will be used to transfer the data into the renewed System.
- Implement at least one report where the Revenue Service data will be used.

3. IOM Project to which the Consultant is contributing

“Effective Migration Governance for Sustainable Return and Reintegration of Georgian Citizens” (IOM reference: MS.0011).

4. Responsibilities and Required Qualifications / Work Experience

4.1 General requirements:

- Previous knowledge and practical experience of working with big data systems, such as the UMAS system, and experience in migration data processing will be considered a strong asset.
